CONDITIONS OF ENTRY

Conditions of Entry

♦ The event will be run according to Speedway New Zealand Inc. Rule Book and is programmed for one day.

License

All drivers must hold a current SNZ License and all vehicles must comply with the current Speedway New Zealand Rule book and supplementary regulations. No day licenses will be issued.

Noise

A noise level of 95 dba will be enforced.

Lapscoring

Electronic lapscoring will be used. Lapscoring will be by way of the Dorian Date-1 Timing/Scoring system. The official transmitters for Electronic Lapscoring are Dorian Data-1 TX8000 and Dorian Direct. No transmitters are available on the night.

Vehicles without a transmitter will not be permitted to race.

Racing Numbers

No duplicate numbers, locally contracted cars to retain numbers. It is a condition of entry that cars
arrive for vehicle checking displaying the number allocated to them by the West Coast Speedway
Association on receipt of entry. Numbers must comply with SNZ ruling (no cardboard/paper
duplicate numbers).

Format

The Promoter reserves the right to alter the format and closing date after consultation with officials, if deemed necessary. You will be notified of any such changes.

Contract

- No telephone entries will be accepted
- In the event that you have already forwarded an entry form and you discover that you are unable to attend this meeting, you must notify the promoter as soon as possible.

Rain Out

♦ In the event of a rainout, the Promoter reserves the right to hold the event on the next most opportune day and time and in accordance with SNZ rules and regulations.

Entry

There is a cost to each vehicle entered of \$5 to assist with the cost for St John. Two people in each tow vehicle receive free entry into the track, if the driver of the race car does not come to the track in the tow vehicle, they must pay to enter.
